Protocol for responding to medical emergencies: (a) One player calls 911, goes to parking lot entrance to direct 911 response vehicle. (b) One player finds car with traffic cone on top, finds defibrillator. (c) On field 1, one Manager goes to Administrative building, finds debibrillator. (d) On Fields 2 and 3, one Manager goes to Snack Bar Building, opens Lock-box, uses key inside to open Snack Bar and finds Defibrillator and brings it to injured player.
